**AFFIDAVIT OF JACK B. GORDON IN SUPORT OF MOTION OF



6. I have not been formally held in contempt or otherwise sanctioned by any court in a written order in the last five years for disobedience to its rules or orders.


7. I have not filed an application to appear *pro hac vice* in this State within the preceding two years.
