AFFIDAVIT OF MARK CHARLES EVERISS



I, MARK CHARLES EVERISS of 43 Fetter Lane, London EC4A 1JU state the following on oath:


1. I am a solicitor of the Supreme Court of England and Wales and a partner in the law firm of Kendall Freeman of 43 Fetter Lane, London, England EC4A 1JU. I have acted for Unionamerica Insurance Company Limited (**Unionamerica**) in relation to the liquidation of The Home Insurance Company (**The Home**) since June 2003.
2. The matters contained in this affidavit are within my own knowledge, information and belief acquired through acting for Unionamerica in this matter except where otherwise appears. Where they are not, I will identify the source of my knowledge, information or belief.
3. I make this affidavit in support of Unionamerica's Objection to the ACE Companies' Motion to Compel Production of Documents. There is now produced and shown to me marked "MCE1" a true copy of a bundle of documents to which I shall refer in this affidavit.

4. I hereby confirm that Unionamerica is a company incorporated under the laws of England and Wales with company number 01022903. Unionamerica's registered office is at 1-1 London Underwriting Centre, 3 Minster Court, Mincing Lane London EC3R 7YJ. This is evidenced by page 1 of Exhibit "MCE1", which is a print-out (made today) from the alphabetical list of companies registered in England and Wales, published on the website maintained by the Registrar of Companies in England and Wales.
  
5. I also confirm that Unionamerica is not licensed by the State of New Hampshire Insurance Department to transact insurance business in New Hampshire. 
