class mail, postage prepaid, using the latest mailing address provided to the Liquidator by the claimant or cedent, to (a) all claimants who filed proofs of claim with the Liquidator and (b) all cedents who have otherwise submitted a claim in the normal course of business to the Liquidator after the entry of the Order of Liquidation, except those claimants/cedents whose claims have been resolved by a commutation agreement with the Liquidator that precludes the submission of additional claims.

3. The Liquidator shall also promptly post the Motion and this Order of Notice in the Merrimack County Superior Court Files section of the liquidation website (www.hicilclerk.org) and on the website of the New Hampshire Insurance Department.
