**LIQUIDATOR'S ASSENTED-TO MOTION TO EXTEND TIME TO
OBJECT TO SWAN TRANSPORTATION'S MOTION TO RECOMMIT**

Roger A. Sevigny, Insurance Commissioner for the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company ("Home"), moves that the Court extend the time in which the Liquidator may object to the motion to recommit filed by Swan Transportation Company from July 16, 2009 to and including July 27, 2009. As reasons therefor, the Liquidator states as follows:

1. On July 6, 2009, the claimant Swan Transportation Company ("Swan Transportation") filed its motion to recommit the Referee's June 18, 2009 Order on the Merits regarding Swan Transportation's claim. The Liquidator's response is accordingly due on July 16, 2009.

2. Counsel for the Liquidator is involved in a recently filed case with an expedited briefing and hearing schedule. Tuttle v. New Hampshire Medical Malpractice Joint Underwriting Association, et al., No. 09-E-148 (Belknap County Superior Court). The Court in that action has directed that dispositive motions be filed July 10, and replies are to be filed July 17, 2009. A final hearing has been scheduled for July 20, 2009.

3. As a result of the expedited schedule in that case and other pending matters, the Liquidator requests that the time in which to file his objection to Swan Transportation's motion to recommit be extended to and including July 27, 2009.

4. Counsel for the Liquidator has consulted with counsel for Swan Transportation, who assents to this motion.

WHEREFORE, the Liquidator respectfully requests that this Court:


- A. Grant this motion and extend the time in which the Liquidator may object to Swan Transportation's motion to recommit to July 27, 2009; and
