**LIQUIDATOR'S RESPONSE TO CLAIMANT OSIJO'S OBJECTION TO  
LIQUIDATOR'S FOURTH MOTION FOR APPROVAL OF DISPOSAL OF CERTAIN  
RECORDS**

Roger A. Sevigny, Insurance Commissioner for the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company ("Home"), responds to the objection filed by Claimant Abedowale O. Osijo ("Claimant") to the Liquidator's Fourth Motion for Approval of Disposal of Certain Records ("Motion").

1. In his objection, Claimant objects to disposal of records of (1) an attorney who represented him in the case underlying Claimant's claim in the Home liquidation, and (2) a law firm that defended that action and a subsequent legal malpractice action. Claimant is apparently concerned that any such files relate to his claim but would fall within the third party files category of Paragraph 7 of the Liquidator's motion.

2. This is not the case. First, the motion only seeks approval to dispose of records concerning claim determinations approved for more than one year. See Motion ¶ 5. Records concerning the Claimant's claim, which is pending in the liquidation pursuant to his motion to recommit, are not addressed by the Liquidator's motion. Second, before disposing of any outside counsel files, the Liquidator will review the inventories to determine whether any files "concern a proof of claim, a pending dispute or anticipated litigation." Motion ¶ 7(i).

Accordingly, if the attorney or law firm has provided or in the future provides the Liquidator with files regarding Claimant's litigation, the files will be retained until after Claimant's claim in the Home liquidation is finally resolved.


3. Accordingly, Claimant's objection should be overruled.


