**FULLER-AUSTIN DEFENDANTS' ASSENTED-TO MOTION
FOR EXTENSION OF TIME TO RESPOND TO THE LIQUIDATOR'S
MOTION FOR APPROVAL OF SETTLEMENT AGREEMENT
WITH WESTERN ASBESTOS SETTLEMENT TRUST**

NOW COME Zurich Insurance Company, Zurich American Insurance Company, Zurich-American Insurance Company of Illinois, American Guarantee & Liability Insurance Company, American Zurich Insurance Company, Steadfast Insurance Company, and Orange Stone Reinsurance (the "*Fuller-Austin* Defendants"), and move for an extension of time until April 1, 2011, to respond to the Liquidator's Motion for Approval of Settlement Agreement with Western Asbestos Settlement Trust. 
