MOTION FOR EXTENSION OF TIME TO OBJECT TO
CENTURY INDEMNITY COMPANY'S MOTION TO RECOMMIT (KENTILE)**

Roger A. Sevigny, Insurance Commissioner for the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company ("Home"), and Metex Mfg. Corporation ("Metex"), a participant in the proceeding before the Referee, move that the Court extend the time to object to Century Indemnity Company's Motion to Recommit the Referee's Ruling on Kentile Floors, Inc., by 15 days (from June 30, 2014 until July 15, 2014). As reasons therefor, the Liquidator and Metex state as follows:

1. On June 18, 2014, Century Indemnity Company ("CIC") filed a Motion to Recommit the Referee's Ruling on Kentile Floors, Inc. CIC's motion requested that the Court recommit the Referee's May 20, 2014 Order on the Merits issued in disputed claim proceeding 2005-HICIL-14 (Kentile). (CIC had requested and the Liquidator had assented-to a motion to extend time to file the motion to recommit from June 4, 2014 to June 18, 2014).

2. Metex was allowed to participate in 2005-HICIL-14 (Kentile) pursuant to the Referee's Order on Metex' Motion to Intervene and Participate in Dispute Regarding Kentile dated December 17, 2013.

3. In order to allow for proper briefing of the issues presented in the motion to recommit in light of other commitments, the Liquidator and Metex request the 15-day extension.

4. Counsel for CIC has been contacted and assents to the requested extension of time.

WHEREFORE, the Liquidator and Metex respectfully request that the Court grant this motion and extend the time to object to CIC's motion to recommit to and including July 15, 2014.
