

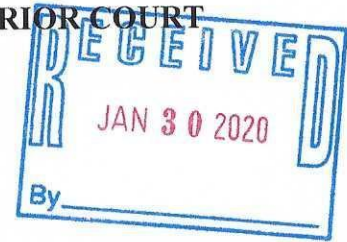


WHEREFORE, J&J respectfully requests that this Court enter an order:
