AFFIDAVIT OF JANICE OLIVER

I, Janice Oliver, hereby declare and say:

1. I am Mailing Customer Service of NH Print & Mail Services, 30 Terrill Park Drive, Concord, N.H. 03301, a position I have held since 2015. NH Mail & Print Services' business includes printing and bulk mailing services.

2. In August, 2019, NH Print & Mail Services was engaged by the Liquidator of The Home Insurance Company to print and mail a notice. I coordinated that mailing for NH Mail & Print Services.

3. On September 10 and 11, 2019, Sue Demers of the Home liquidation staff emailed me a form of notice and a mailing list spreadsheet listing the names, addresses and proof of claim (POC) numbers for 2,186 persons to be mailed the notice. A copy of the form of notice is attached as Exhibit A, and a copy of the spreadsheet is attached as Exhibit B. Ms. Demers also requested that NH Print & Mail Services print window envelopes for the mailing with a return address and the legend "Important-Notice re Motion for Approval of Claim Amendment Deadline". The envelopes had glassine windows to show the name and address. A copy of the form of envelope showing the return address and legend is attached as Exhibit C.

4. Using the form of notice and the information from the spreadsheet, NH Mail & Print Services printed a notice for each name and address on the spreadsheet bearing the name, address and POC number(s). NH Mail & Print Services then placed the notices in the envelopes, affixed postage and delivered the envelopes containing the notices to the United States Postal Service.

5. NH Mail & Print Services printed and mailed the notice to each of the 2,186 names and addresses on the spreadsheet. It mailed 129 notices to persons with addresses outside the United States by first class mail – international, postage prepaid, on September 12, 2019, and 2,057 notices to persons with addresses in the United States by first class mail, postage prepaid, on September 13, 2019.

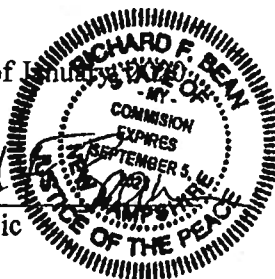

APPROVAL OF CLAIM AMENDMENT DEADLINE REGARDING

To Persons who have open proofs of claim in the liquidation of The Home Insurance Company ("Home"):

Home is in liquidation proceedings before the Merrimack County Superior Court of the State of New Hampshire (the "Court"), In the Matter of the Liquidation of The Home Insurance Company, Docket No. 217-2003-EQ-00106.

John R. Elias, Insurance Commissioner of the State of New Hampshire, as Liquidator ("Liquidator") of Home, has filed a Motion for Approval of Claim Amendment Deadline to set a deadline of 150 days after the Court's order granting the Liquidator's motion for the final submission of amendments to proofs of claim in the Home liquidation. As described in that motion, claims filed after the claim amendment deadline and potential claims (any claim that cannot be specifically identified by the claim amendment deadline) will be barred, and certain claimants may be required to amend their proofs of claim, if the motion is granted. The Liquidator's motion and the proposed order filed August 1, 2019 may be found in the Home liquidation file in the Merrimack County Superior Court Files section of the Home Liquidation Clerk website, www.hicilclerk.org, and also on the Claim Amendment Deadline Filings page of that website at <http://www.hicilclerk.org/Hicil.nsf/CADFilings?readform>.

The Court has set a deadline of November 18, 2019 for the filing of any objections to the Liquidator's Motion for Approval of Claim Amendment Deadline. Any objections to the motion shall be filed on or before November 18, 2019 with the Clerk, Merrimack County Superior Court, 163 North Main Street, Concord, New Hampshire 03301 in In the Matter of the Liquidation of The Home Insurance Company, Docket No. 217-2003-EQ-00106.

Copies of any objection shall also be served on counsel for the Liquidator: J. Christopher Marshall, Civil Bureau, New Hampshire Department of Justice, 33 Capitol Street, Concord, NH 03301-6397 and J. David Leslie/Eric A.
