**NOTICE OF THE RESOLUTE OBJECTORS JOINDER IN THE
INTERLOCUTORY APPEAL STATEMENT OF ZURICH AND THE LIQUIDATOR**

Indemnity Marine Assurance Company, Nederlandse Reassurantie Groep NV, NRG Victory Reinsurance Ltd, NRG Fenchurch Insurance Company Ltd, New Zealand Reinsurance Company, Tenecom Ltd, Underwriters of Lloyd's of London, Winterhur Swiss Insurance Company and World Auxiliary Corporation Limited (collectively, "**Resolute Objectors**"), by and through their attorneys, Pastori | Krans, PLLC and Day Pitney LLP submit this notice of joinder in the Interlocutory Appeal Statement submitted by Zurich Insurance plc, German Branch ("**Zurich**") and the Insurance Commissioner of the State of New Hampshire, as Liquidator for the Home Insurance Company ("**Liquidator**"), dated May 12, 2021 (the "**Interlocutory Appeal Statement**").

The Resolute Objectors are included among the group of AFIA Cedents referred to in the Interlocutory Appeal Statement, as such the Resolute Objectors have an interest in Class I administrative expenses pursuant to the AFIA Agreement and an interest in submitting IBNR claims that the Claim Amendment Deadline seeks to prematurely terminate. The Resolute Objectors concur with Zurich and the Liquidator that the New Hampshire Supreme Court's resolution of the Questions Presented in the Interlocutory Appeal Statement will assist the orderly administration of the liquidation.


