LIQUIDATOR'S CERTIFICATE OF COMPLIANCE WITH CLAIM AMENDMENT DEADLINE ORDER

Christopher R. Nicolopoulos, Insurance Commissioner of the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company ("Home"), submits this certificate to report that he has complied with the notice provisions of the Order Approving Claim Amendment Deadline.

- 1. As set forth in the Liquidator's September 1, 2022 Report Regarding Claim
 Amendment Deadline Set at January 26, 2023 ("Liquidator's CAD Report"), the Court issued its
 Order Approving Claim Amendment Deadline on January 28, 2021 ("CAD Order"). The CAD
 Order was affirmed by the New Hampshire Supreme Court on interlocutory appeal. *In the*Matter of the Liquidation of The Home Insurance Company, No. 2021-0211 (N.H. Aug. 12,
 2022). The CAD Order became effective when the New Hampshire Supreme Court issued its
 mandate on August 29, 2022.
- 2. CAD Order required the Liquidator to provide mail notice of the Claim

 Amendment Deadline within 30 days of receipt of the Order. CAD Order ¶ 12. It also required that the CAD Order and the notice be posted on the Home Liquidation Clerk website. CAD

 Order ¶ 13. The Liquidator submits this certificate to report compliance with these requirements.
- 3. Paragraph 12 of the CAD Order required the Liquidator to mail notice of the Claim Amendment Deadline in the form attached to the Order by first class mail, postage

prepaid, to all claimants who have open proofs of claim (as defined in the Order) in the Home liquidation and, where a claimant is represented by counsel, also to counsel, within 30 days from receipt of the CAD Order. Mail to foreign addresses was to be by air mail, postage prepaid.

- 4. The Liquidator has complied with these requirements. The Liquidator compiled mailing lists of claimants with open proofs of claim (as defined) as of September 15, 2022, and their counsel. The lists totaled 2,416 claimants and counsel. The Liquidator retained New Hampshire Print Mail to print and mail the approved notice to 2,381 claimants and counsel in envelopes with the legend "Important Notice of Claim Amendment Deadline". A copy of the final notice is attached as Exhibit A. New Hampshire Print and Mail mailed the notice to the 2,291 domestic claimants and counsel by first class mail on September 21, 2022 and to the 90 foreign claimants and counsel by first class mail international (the current equivalent of air mail) also on September 21, 2022. The liquidation team in New York separately mailed the notice to the remaining 35 claimants and counsel on September 22, 2022.
- 5. Paragraph 13 of the CAD Order required the Liquidation Clerk to promptly post the CAD Order and the approved notice to the Merrimack County Superior Court Files and the Key Documents Relating to the Liquidations sections of the Home Liquidation Clerk website (www.hicilclerk.org).
- 6. The Liquidator has complied with those requirements. The CAD Order and the approved notice were posted to the Superior Court Files section of the website on September 1, 2022 as attachments to the Liquidator's CAD Report. The CAD Order was also separately posted to the Key Documents section and Claim Amendment Deadline section of the website on August 31, 2022, while the notice was separately posted to those sections of the website on September 6, 2022.

NOTICE OF CLAIM AMENDMENT DEADLINE FOR THE HOME INSURANCE COMPANY, IN LIQUIDATION

To Persons who have open proofs of claim in the liquidation of The Home Insurance Company ("Home") and other persons:

Home is in liquidation proceedings before the Merrimack County Superior Court of the State of New Hampshire (the "Court"), In the Matter of the Liquidation of The Home Insurance Company, Docket No. 217-2003-EQ-00106. Christopher R. Nicolopoulos, Insurance Commissioner of the State of New Hampshire, is the Liquidator of Home ("Liquidator").

The Court has established January 26, 2023 as the Claim Amendment Deadline for the final amendment of proofs of claim or submission of proofs of claim in the Home liquidation. Claims against Home must be received by the Liquidator or postmarked by U.S. mail on or before the Claim Amendment Deadline at the address set forth above or they will be barred from sharing in any distribution of assets from the Home estate. "Post Claim Amendment Claims" and "Potential Claims" as defined the Order Approving Claim Amendment Deadline dated January 28, 2021 (affirmed August 12, 2022, effective August 29, 2022) are barred and will not be considered. The Order Approving Claim Amendment Deadline is available in the "Key Documents Relating To The Liquidations" section of the Home Liquidation Clerk website, www.hicilclerk.org., at http://www.hicilclerk.org/Hicil.nsf/vwAllOtherDocs?ReadForm&Key+Documents.

If you have an open proof of claim in the Home liquidation, you have until January 26, 2023 to amend your proof of claim to supplement or update your claim. If you add a claim, you must include an explanation of why the claim was not filed by the June 13, 2004 claim filing deadline with your amendment. If your open proof of claim seeks coverage under a Home policy or reinsurance contract for Potential Claims, you must amend your proof of claim to make it specific by identifying and providing the particulars of all claims for which coverage is sought.

Any new proofs of claim in the Home liquidation must be filed on or before January 26, 2023. The proof of claim form and instructions may be obtained by downloading them from the "Key Documents Relating To The Liquidations" section of the website for the liquidation, www.hicilclerk.org, by calling 1-800-347-0014 during regular business hours (Monday-Friday 8-5 ET), or by writing to the address above. You must include an explanation of why your proof of claim was not filed by the June 13, 2004 claim filing deadline with your proof of claim.

If you have been issued a notice of determination as to Class V priority only, deferring determination as to amount, you have until January 26, 2023 to amend your proof of claim and include an explanation of why your proof of claim should be determined as to amount. In the absence of an amendment, the previous notices of determination shall be considered final determinations, and the Liquidator need not make any further determination on your proof of claim.

Your submission must include available supporting information regarding your claim.

Amendments and proofs of claim must be <u>received</u> by the Liquidator <u>or legibly postmarked by U.S. mail</u> on or before the January 26, 2023 Claim Amendment Deadline. Amendments and proofs of claim received or postmarked after the Claim Amendment Deadline will <u>not</u> be considered.
