CLAIMANT'S AND LIQUIDATOR'S REQUEST TO EXTEND BRIEFING SCHEDULE

The Arizona Property and Casualty Insurance Guaranty Fund ("Claimant") and Roger A. Sevigny, Insurance Commissioner of the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company, hereby request that the Referee extend the briefing schedule in these consolidated proceedings as set forth below. As reasons therefor, the parties state:

1. By orders dated May 8, 2012 and June 19, 2012, the Referee approved the parties' proposed briefing schedule, so the submissions in this matter are presently due as follows:
 - a. Claimant's submission due July 11, 2012
 - b. Liquidator's submission due August 11, 2012 (30 days after service of Claimant's submission)
 - c. Claimant's reply, if any, due August 26, 2012 (15 days after service of Liquidator's submission)
 - d. Telephonic argument at a convenient date thereafter
2. Claimant has requested that the briefing schedule be extended to provide time for discussion of the issues by the Liquidator and the Claimant.
3. The parties accordingly request that the briefing schedule in this matter be extended to the following:

- a. Claimant's submission due July 30, 2012
- b. Liquidator's submission due August 29, 2012
- c. Claimant's reply, if any, due September 13, 2012
- d. Telephonic argument at a convenient date thereafter

WHEREFORE, the parties request that the Referee extend the briefing schedule to that set forth in paragraph 3 above.




