**LIQUIDATOR'S AND CLAIMANT'S  
JOINT PROPOSAL RE BRIEFING SCHEDULE**

Pursuant to the Referee's Scheduling Orders dated January 18, 2012, Roger A. Sevigny, Insurance Commissioner of the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company and the Arizona Property and Casualty Insurance Guaranty Fund ("Claimant") submit this joint proposal regarding a briefing schedule.

1. In accordance with the Scheduling Order, the parties have conferred concerning the need for additional discovery. Aside from certain follow-up documents requested by the Liquidator, which the Claimant is providing, the parties do not need any additional discovery.

2. The parties accordingly jointly propose the following schedule for submissions pursuant to § 15 of the Restated and Revised Order Establishing Procedures Regarding Claims Filed with The Home Insurance Company in Liquidation dated January 19, 2005:

- a. Claimant's submission due 45 days after the Referee issues a scheduling order
- b. Liquidator's submission due 30 days after service of Claimant's submission

- c. Claimant's reply, if any, due 15 days after service of Liquidator's submission
- d. Telephonic argument at a convenient date thereafter




