**LIQUIDATOR'S ASSENTED-TO MOTION TO FILE EXHIBIT UNDER SEAL**

Roger A. Sevigny, Insurance Commissioner of the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company ("Home"), hereby requests that the Referee order that an exhibit to the Liquidator's brief in this matter – a settlement agreement between Claimants Melvin Holson and Sheldon Holson (the "Holsons") and an insurer, Fireman's Fund Insurance Company ("Fireman's Fund") – be filed under seal. As reasons therefor, the Liquidator states:

1. The Liquidator is preparing to file his brief on coverage issues in accordance with the Referee's scheduling order dated March 17, 2009. The Liquidator's brief will be filed with exhibits necessary for an understanding of this dispute.
2. One of the exhibits will be a 1999 settlement agreement between the Holsons and Fireman's Fund that concerns the same litigation (the KVL Action) that underlies this disputed claim proceeding.

3. The Fireman's Fund settlement provides that it is confidential, and it was provided to Home by the parties on the condition that it be treated as confidential and not distributed to third parties.


4. The Liquidator accordingly moves to file the Fireman's Fund settlement under seal.

5. Counsel for the Liquidator has consulted with counsel for the Holsons, and the Holsons assent to this motion.

WHEREFORE, the Liquidator requests that the Referee issue an order directing that the Fireman's Fund settlement agreement be filed under seal.


