In Case No. 2021-0211, <u>In the Matter of Rehabilitation of The Home Insurance Company</u>, the court on July 26, 2021, issued the following order:

Interlocutory appeal from ruling is accepted and will be scheduled for oral argument before the full court.

According to the interlocutory appeal statement, a transcript of the December 11, 2020 superior court hearing is necessary for this appeal. A copy of that transcript was included in volume I of the interlocutory appeal statement appendix, at pages 41 through 113. The certified, digitally-signed transcript having since been provided by eScribers and having been filed in the clerk's office, the case will proceed to briefing.

The brief of Zurich Insurance plc, German Branch, must be filed on or before August 25, 2021. Opposing briefs must be filed on or before September 24, 2021. "Parties supporting the position of the moving party [Zurich Insurance plc, German Branch] shall meet the time schedule provided for that party." See Rule 7(4).

If a brief is not e-filed, a party is requested, but is not required, to submit an electronic copy of the party's brief on a computer-readable compact disk (CD). The electronic copy should be in Portable Document Format (PDF). The electronic copy should contain the entire brief, but need not contain documents that are not computer-generated by the party. The label of the CD should include the case name and the case number, and should identify the brief being filed (e.g., plaintiff's opening brief, defendant's opposing brief, petitioner's reply brief).

NOTE: Your brief must not exceed 9,500 words. <u>See</u> Rule 16(11). If you are the appealing party, you must submit a copy of any decision(s) being appealed with your brief in compliance with Rule 16(3)(i).

An appealing party is responsible for providing the court with the necessary record to decide the appeal. Failure to do so may result in dismissal of the appeal. For information about how to provide the

court with the record, review Rule 13 carefully. If you intend to file an appendix to your brief, review Rule 17.
