**ASSENTED-TO NOTICE OF AUTOMATIC EXTENSION OF
TIME TO FILE BRIEF**

Appellant Zurich Insurance plc, German Branch (“Zurich”), through its counsel, McLane Middleton, Professional Association, and with the assent of counsel for the Appellee, hereby provides notice pursuant to Supreme Court Rule 21 (6-A) of an automatic extension of time for filing its brief in this matter. In furtherance of this notice, Zurich states:

1. On July 26, 2021, the Court issued an order containing a briefing schedule, pursuant to which Appellant’s brief was due on or before August 25, 2021 and opposing briefs were due on or before September 24, 2021.

2. Zurich requires an additional 15 days to file its brief. Pursuant to this Notice and Rule 21 (6-A)’s limitation to extend briefing dates no more than 15 days, the briefing dates are as follows: Appellant’s brief will be due on September 9, 2021. Any opposing brief will be due on October 11, 2021, and Appellant’s reply brief will be due on November 1, 2021.
